North Korea Says It Tested And Deployed "Tactical Nuke" Cruise Missiles

SEOUL : (AGENCY)

Kim Jong Un supervised the launch of two long-range cruise missiles, state media said Thursday, adding that the weapons had already been deployed to "tactical nuke" units of the North Korean army.

Kim has overseen a blitz of ballistic missile launches in recent weeks, which Pyongyang has described as tactical nuclear drills that simulated taking out airports and military facilities across South Korea.

The Wednesday test of the two cruise missiles aimed at "enhancing the combat efficiency" of the weapons, which were "deployed at the units of the Korean People's Army for the operation of tactical nukes," KCNA reported.

The cruise missiles -- which travel at lower altitudes than ballistic missiles, making them harder to detect and intercept -- flew 2,000 kilometres (1,240 miles) over the sea before hitting their targets, the Korean Central News



Agency said Kim expressed "great satisfaction" with the tests, which he said showed the country's nuclear combat forces were at "full preparedness for actual war" and sent a "clear warning to the enemies," KCNA said.

With talks long stalled, and Ukraine-linked gridlock at the United Nations stymying the chance of fresh sanctions, Kim has doubled down on developing and testing his banned nuclear arsenal. Officials in Seoul and Washington have been warning for months

that Pyongyang is ready to conduct another nuclear test -- which would be the country's seventh.

Kim said North Korea will "focus all efforts on the endless and accelerating development of the national nuclear combat armed forces," KCNA reported Thursday. Pyongyang is not technically banned by the UN from testing cruise missiles, but all ballistic missile launches violate sanctions and are typically flagged by Seoul or Tokyo. Neither had alerted the Wednesday test.

Kim made acquiring tactical nukes -- smaller, lighter weapons designed for battlefield use -- a top priority at a key party congress in January 2021.

"The latest test means the North is operating tactical nuclear capability on cruise missiles, which are harder to detect for their low-altitude flight," Hong Min of the Korea Institute for National Unification told AFP. "It is a testament to Pyongyang's capability to mount nuclear warheads," he said, adding that cruise

missiles can also have irregular flight paths making them harder to intercept.

North Korea revised its nuclear laws last month to allow preemptive strikes, with Kim declaring North Korea an "irreversible" nuclear power -- effectively ending the possibility of negotiations over its arsenal. Since then, Seoul, Tokyo and Washington have ramped up combined military exercises, including deploying a nuclear-powered US aircraft carrier to the area twice, infuriating Pyongyang, which sees such drills as rehearsals for invasion.

In response, North Korea organised drills that it said earlier this week had gamed out hitting South Korea's ports, airports and military command facilities with tactical nukes. North Korea has tested "strategic" cruise missiles before but this is the first time it has said they have a nuclear role and are operational -- although analysts question Pyongyang's claims, saying it has not shown it can actually make nuclear warheads small enough.

Picasso's First Lover More Than A Victim In Paris Expo

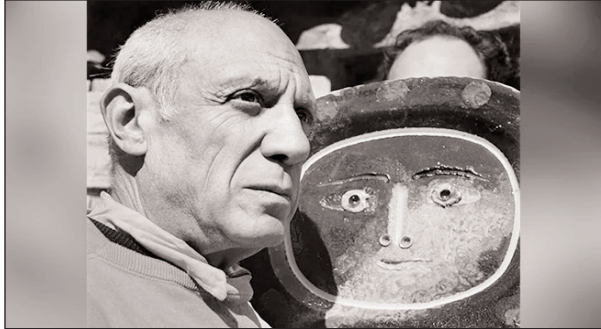
Fifty years on from Pablo Picasso's death -- and five years after the #MeToo movement started highlighting celebrities' abuse of women -- a new exhibition in Paris focuses on one of the early partners of the controversial artist. If Picasso's reputation has taken a battering in the post-MeToo world, it is in part due to his treatment of Fernande Olivier, his first serious partner.

But for Cecile Debray, director of the Picasso Museum in Paris, we cannot just view the artist few the prism of modern-day sensibilities. Possessive and jealous, Picasso would lock Olivier in their ramshackle Paris apartment when he went out and made sure she doted on him while he worked long into the night.

This should not however overshadow the story of their time together, say the organisers of a new exhibition at the Montmartre Museum, in the north of Paris. The new show puts pages from her memoirs alongside dozens of paintings and sculptures by Picasso and others from

that famous artists' circle. "Picasso, due to a sort of morbid jealousy, kept me as a recluse," Olivier wrote

trayed, said Debray. Their relationship ended after eight years in 1912, just as Picasso was gaining serious



in her diary. "But with tea, books, a divan and little cleaning to do, I was happy, very happy." But her writings show she was more than a victim, said Debray. Debray, who is overseeing the anniversary celebrations, has criticised recent "ahistorical" attacks on the artist for his treatment of women. "It was a relationship almost of equals," she told AFP. "Certainly, he was jealous, worked a lot... but he was also tender and loving, the only lover of that type that Fernande Olivier ever had." He was more than just the "minotaur", the monster, that some recent accounts have por-

renown. Twenty years later, Olivier published a book about the period, "Picasso and his Friends", which the artist tried to ban. Her memoirs revealed a difficult life beyond their time together. She was abandoned by her parents and raised by an unloving aunt, then forced into a marriage with a violently abusive husband before she fled and eventually met Picasso. "They provide a look at the condition of women generally at the start of the century that is very raw and realistic, as well as of a hard worker who did many little jobs to stay independent beyond her marriage.

Day After UN Resolution, Russian Missiles Target Over 40 Ukrainian Cities, Towns

KYIV : (AGENCY)

Russian missiles pounded more than 40 Ukrainian cities and towns, officials said on Thursday, after a United Nations General Assembly resolution called Moscow's annexation of Ukrainian territory "illegal" and Ukraine's allies committed more military aid.

Russia repeated its position that the West, by helping Ukraine, indicated that "they are a direct party to the conflict" and warned the admission of Ukraine to NATO could trigger World War Three.

"Kyiv is well aware that such a step would mean a guaranteed escalation to a World War Three," deputy secretary of the Security Council of the Russian Federation, Alexander Venediktov, told the state TASS news agency on Thursday.

Ukrainian President Volodymyr Zelenskyy announced a surprise bid for fast-track membership of the NATO military alliance at the end of September, after Russian President Vladimir Putin held a ceremony in Moscow to proclaim four partially occupied regions as

annexed Russian land. In the past 24 hours Russian missiles hit more than 40 settlements, while Ukraine's air force carried out 32 strikes on 25 Russian targets, Ukraine's Armed Forces General Staff said. Mayor of the port city of Mykolaiv,



Oleksandr Senkevich, said in a social media post that the southern city was "massively shelled". "A five-storey residential building was hit, the two upper floors were completely destroyed, the rest - under rubble. Rescuers are working on the site," he said. A ship-building centre and a port on the Southern Bug river off the Black Sea, Mykolaiv has suffered heavy Russian bombardments throughout the war. Russia also target-

ed a settlement in the region of Ukraine's capital Kyiv using explosive drones early on Thursday, the region's administration said on the Telegram messaging app. Governor of the Kyiv region, Oleksiy Kuleba, said based on preliminary infor-

mation the strikes were caused by Iranian-made loitering munitions. These are often known as "kamikaze drones".

Critical infrastructure facilities were hit by the drones, said Kyrlyo Tymoshenko, the deputy head of Zelenskyy's office. Missiles struck more than 30 multi-storey and private houses, gas pipelines and power lines in the city of Nikopol in the Dnipropetrovsk region, and

more than 2,000 families were left without electricity, Dnipropetrovsk Governor Valentyn Reznichenko wrote on Telegram.

Reuters was not able to immediately verify the report. NATO's secretary-general, Jens Stoltenberg, said Russia's missile attacks were a sign of weakness. "Russia is actually losing on the battlefield," Stoltenberg said.

As his forces have lost ground since September, Putin has intensified the conflict, ordering the call-up of hundreds of thousands of reservists, proclaiming the annexation of occupied Ukrainian territory and repeatedly threatening to use nuclear weapons to protect Russia. Putin has threatened to use nuclear weapons to protect Russian soil, which he says includes the four regions he declared annexed last month. US President Joe Biden said on Wednesday he doubted Putin would resort to nuclear weapons.

A senior NATO official said a Russian nuclear strike would almost certainly trigger a "physical response" from Ukraine's allies and potentially NATO.

पुलिस ने अमृतसर एयरपोर्ट से हिरासत में लिया जगतार सिंह, दुबई भागने की कर रहा था कोशिश

अमृतसर (एजेंसी) । सिद्धू मूसेवाला हत्याकांड में पुलिस ने एक बार फिर बड़ी कार्रवाई की है। दरअसल पुलिस ने श्री गुरु रामदास अंतरराष्ट्रीय एयरपोर्ट पर जगतार सिंह नामक एक व्यक्ति को हिरासत में लिया है।दुबई है कि जगतार सिंह मूसेवाला हत्याकांड में वांछित है और यहां से दुबई की फ्लाइट पकड़कर भागने की फिराक में था। इस बाबत मानसा पुलिस ने



जगतार का एलओसी (लुक आउट सर्कुलर) जारी करवा रखा था।द जैसे ही जगतार सिंह एयरपोर्ट पर फ्लाइट पकड़ने पहुंचा तो अथारिटी ने उसे पकड़ लिया। इसके बाद उसे अमृतसर पुलिस के हवाले कर दिया गया।द पता चला है कि जगतार सिद्धू मूसेवाला का पड़ोसी है और उसके घर के नजदीक रहता है। अमृतसर पुलिस अधिकारियों का कहना है कि पूछताछ में जगतार सिंह ने स्वीकार किया है कि उक्त मामले में वह इन्वेस्टिगेशन ज्वाइन कर चुका है।द फिलहाल घटना के बारे में मानसा पुलिस को जानकारी दे दी गई है। साथ ही आगे की जांच जारी है। पूछताछ में कई और भी खुलासे हो सकते हैं। गौरतलब है कि पंजाबी गायक व कांग्रेस नेता सिद्धू मूसेवाला की इसी साल 29 मई को गोलियां बरसा कर हत्या कर दी गई थी। उनपर हमला तब किया गया जब वो अपनी बीमार मौसी का हाल जानने निकल थे। इस दौरान आठ शूटरों ने फायरिंग की थी, जिसमें हरियाणा के गैंगस्टर भी शामिल थे। सिद्धू मूसेवाला को इस दुनिया से गए चार महीने से ज्यादा का समय बीत चुका है, पर फैस उनको अभी तक भुला नहीं पा रहे हैं। उनके गाने आज भी देश ही नहीं बल्कि विदेश में भी गुंजते रहते हैं।

पानीपत में सस्ते में डालर पाने के लालच में क्लिनिक संचालक से 1लाख 70 हजार रुपये की धोखाधड़ी

पानीपत (एजेंसी) । पानीपत के गांव सौधापुर का रहने वाला क्लीनिक संचालक रमेश कुमार लालच में धोखा खा बैठा। जब एक महिला ने उसे सस्ते में डालर देने का झांसा देकर 1.70 लाख रुपये ठा लिए। मामला बुधवार दोपहर के समय का है। महिला उनके साथ ठगी कर फरार हो गई। अब उसका फोन तक नहीं मिल रहा है। रमेश कुमार ने समालखा चौकी पुलिस को दी शिकायत में बताया कि वह पेशे से डॉक्टर है। उसका पानीपत किशनपुरा में क्लीनिक है। एक सप्ताह पहले उसके पास एक महिला दवाई लेने के लिए आई थी। उसने पैसे के बदले डालर कम रेट में देने की बात



की। उसने महिला से डालर कहा से लाने बो पूछ तो उसने बताया कि समालखा में मेरी मौसी के पास बहुत सारे डालर है। जोकि आपको सस्ते में दिलावा दूंगी। क्लीनिक संचालक ने बताया कि महिला के कोहे मुताबिक 12 अक्टूबर, बुधवार को वह समालखा आ गया। महिला ने कहा कि पांच लाख के डालर है। आप तीन लाख में ले जाओ। उन्होंने तीन की बजाय दो लाख में बात की तो वह मान गई। रमेश ने बताया कि महिला ने पहले तो उन्हें असल डालर दिखाए और फिर पांच मिनट के लिए अंदर गई। वापस आकर उसने पैसे मांगे। महिला के कहने पर उन्होंने 1.70 लाख रुपये दिए और उससे बैग ले लिया। गाड़ी में बैठने के बाद उन्होंने बैग में डालर चैक किए तो डालर की बजाय कागज मिले। इस पर वह दंग रह गई और उन्होंने महिला की काफी तलाश की, लेकिन कोई पता नहीं चल पाया। उनका कहना है कि महिला का मोबाइल नंबर भी नहीं मिल रहा है।

हरियाणा में मौसरी बहन को ले भागा कलयुगी बेटा, मां से बोला- इतनी गोलियां चलाऊंगा कि जिंदा बचना नामुमकिन है

हरियाणा में गरजा बुलडोजर, चर्चित बदमाश बिल्लू के अवैध कब्जों पर कर्करवाई, ध्वस्त किया निर्माण
